# Innovatec Financial Results \* 2020 Figures pro-forma integrated with Clean Tech group net Sostenya Green S.p.A. dismissal







HY21 Revenues up 60% driven by House Verde (€21,2 mln out of €24,5 mln EE). HY21 Revenues increase Environment business up to €38 mln (1H20 €32 mln) mainly due to increase on volumes and prices

The trend in revenues was reflected in HY21 EBITDA: EE contributes €4 (30%). Environment contributes €10 mln (70%)

The cash generation deriving from operations in HY21 led to a further increase in the consolidated NFP which rose from €10 mln (2020) to €16 mln HY21 confirming the solidity of the group

HY21 Revenues up 60% driven by House Verde to €64 MM

Clean Tech contribution to consolidated results will stabilize revenues and margins of Innovatec's core business, energy efficiency, characterized instead by greater volatility in relation to the incentive policies in force
