

- Innovatec S.p.A. is a leading Energy Efficiency and Renewable group of companies listed on the AIM Italy stock exchange. Having recently acquired 50,1% of Clean Tech Luxco SA, Innovatec aims to become a leading operator in the Clean Tech industry
- Pro-forma consolidated results: In FY2020 revenues were € 85 million, EBITDA equal to € 16 million with a margin of 19% and the Net Result of € 2.3 million. 2020 Net Equity is equal to € 17 million and the Cash net debt is positive at € 10.3 million, improved vs 2019.
- Listed on AIM Italia since 2013 and certified ESCO UNI CEI 11352, it counts a portfolio of over 2,000 clients
- With the 110% Superbonus incentives, the Company expects an important boost on energy efficiency business in the retail segment. As of 4 May 2021, the preliminary contracts exceeds € 115 million of which € 28million turned to definitive. Thanks to the new contracts innovatec reaches the objectives set for the year 2021 with advance of six months and aims to double for the current year by setting the target of the final HouseVerde contracts for 2021 at € 50 million
- INNOVATEC CIRCLE: New operating sub holding for the enhancement of the plants currently owned by the Group and the implementation of new projects related to the circular economy, in line with the forecasts of the Recovery Plan:

Planned Investments: €30M up to 2023, Turnover 2023: €60M (2020: €32M)
